## **Privacy Policy**

#### Introduction

This Privacy Policy, in conjunction with our Privacy Notice, (Privacy Notice available below and at LennarMortgage.com), explains how Lennar Mortgage, LLC ("Lennar Mortgage," "we," "us," or "our") collect, use and disclose personal information about visitors to our websites, people we meet in person or by phone, our customers and prospective customers (each, "Consumer", "you," or "your"), and others whose personal information we collect and retain.

This Privacy Policy applies to:

- Information we receive and collect through LennarMortgage.com ("Site") and any mobile application provided by or on behalf of Lennar Mortgage (collectively, our "Online Services"); and
- Information we receive and collect through email and other electronic means, off-line communications and in-person contacts (collectively with Online Services, "Services").

Lennar Mortgage Affiliates is defined in our Privacy Notice under "Affiliates."

#### 1. Personal Information We Collect

#### What is Personal Information?

The term "personal information" as used in this Privacy Policy refers to information that identifies you as an individual or relates to you as an identifiable individual. We collect your personal information from you through your use of the Services, including the following types of personal information:

#### Personal Information You Provide

Depending on how you interact with our Services, we will collect the following personal information that you voluntarily provide to us for the following purposes:

- *Create an Account*. If you create an account, you will provide us with your name, email address, phone number, and you will create a username and password for future logins.
- *Get Pre-Qualified*. To get pre-qualified, you will provide us with your login credentials, name, email address, date of birth, social security number, citizenship status, marital status, phone number, and physical address.
- Apply for a Mortgage Loan. To apply for a loan with Lennar Mortgage, you will provide us with your login credentials, name, email address, date of birth, social security number, citizenship status, marital status, phone number, and physical address, employment and income information, credit history, purchase property address, and any other additional information we may ask you to provide to assist us with rendering a credit decision. See additional details in Personal Information We Collect.
- *Contact Us.* If you contact us, you will provide us with your name, email address, phone number, city of residence, state of residence, and any other information you choose to include.
- *Find a Branch*. If you search for a branch in your area, you will provide us with your zip code.
- Careers. If you apply for a job with us, you will provide us with your name, email address, phone number, physical address, employment history, and any other information you choose to provide. Our careers page is provided by iCIMS. iCIMS may collect, record, and store the information you provide in your application. Please review iCIM's privacy policy <u>here</u>.
- Share Your Story. If you provide feedback, you will provide us with your name, email address, city of residence, state of residence, and any other information you choose to include.

## Personal Information as You Navigate Our Online Services

We automatically collect certain personal information through your use of our Online Services and our use of cookies and other online technologies. This personal information includes:

- *Identification Information* Any prior visits to the Online Services, your username and password to access your Lennar Mortgage Account and other personalized services.
- *Device Information* Your IP address, browser type, operating system and other usage information about the use of our Online Services.
- Usage Information Browsing history, search history, and information regarding your interactions with our Online Services and other websites, applications, or advertisements.
- Location Information Your IP address or mobile device identification transmits general information about your geolocation, and you may allow us to obtain more specific geolocation information.

## 2. How We Use Your Personal Information

In addition to the purposes stated above, we may use all the personal information we collect in accordance with applicable law such as to:

- Establish, maintain and service our customer accounts, provide customer service, process and or fulfill requests for information, contracts, orders and other transactions, verify customer information, provide financing, title, insurance or other home purchase related services through Lennar Mortgage Affiliates, and to engage in advertising, marketing, and online analytic services;
- Process payment information for transactions with Lennar Mortgage;
- Undertake activities to maintain the quality of Lennar Mortgage products and services and to improve, upgrade, and enhance those products and services, including research and development;

- Manage our Online Services to maintain functionality, assess our users' feedback so that we present information on your computer or mobile device in a user-friendly way, and to detect security incidents and protect against malicious, deceptive, fraudulent, or illegal activity and take appropriate action if needed;
- Manage our contractual relations, protect our business interests, enforce our terms and conditions and comply with applicable laws by monitoring, investigating, and taking other actions to detect and prevent illegal or fraudulent activities and risks to the personal safety of any individual;
- Comply with valid legal process and respond to appropriate governmental requests;
- Facilitate the payment to your creditors if required for your loan transaction, including permitting the escrow service provider to list your full account number on a check or other payment instrument to your creditor;
- Generate an insurance quote by our affiliate insurance company or another insurance company if you opted to receive a quote;
- Fulfill any other purposes for which you provide it; and
- For any purpose that is reasonably necessary to or compatible with the original purpose for which we collected the personal information as disclosed to you.

## 3. How We Share Your Personal Information

We may share the personal information that we collect about you in the following ways:

- With vendors who perform data or Site-related services on our behalf (e.g., email, hosting, maintenance, backup, analysis, etc.);
- To the extent that we are required to do so by law;
- In connection with any legal proceedings or prospective legal proceedings;
- To establish, exercise, or defend our or a third party's legal rights, including providing information to others for the purposes of fraud prevention;
- With any person who we reasonably believe may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information;
- With any other person or entity as part of any business or asset sale, equity transaction, merger, acquisition, bankruptcy, liquidation, or similar proceeding, or in preparation for any of these events;
- With mortgage insurers, government agencies, our investors, warehouse lenders, or other parties who may insure your loan, purchase your loan or have a security interest in your loan;
- With any other person or entity where you consent to the disclosure; and
- For any other purpose disclosed by us when you provide the personal information or for any other purpose we deem necessary, including to protect the health or safety of others.

## 4. Cookies and Other Technologies

Like many other companies, we use cookies and similar technologies on our Online Services (collectively, "Cookie"). Cookies are small files of information that are stored by your web browser software on your computer hard drive, mobile device, or other electronic device (e.g., a tablet).

We use Cookies to:

- Estimate audience size and usage patterns;
- Understand and save your preferences for future visits, allowing us to customize the Online Services to

your individual needs;

- Compile aggregate data about site traffic and site interactions to resolve issues and offer better site experiences and tools in the future; and
- Recognize when you return to the Site.

We set some Cookies ourselves, while separate entities set other Cookies. We use Cookies other entities set to provide us with useful information, to help us improve our Online Services, to conduct advertising, and to analyze the effectiveness of advertising. For example, we use Cookies from Google.

#### Browser Settings

You can block Cookies by changing your Internet browser settings to refuse all or some Cookies. If you choose to block all Cookies (including essential Cookies) you may not be able to access all or parts of the Site.

#### **Google Analytics**

We may use Google Analytics, a web analytics service provided by Google, Inc. Google Analytics uses Cookies to help us analyze how users interact with the Online Services, compile reports on their activity, and provide other services related to their activity and usage. The technologies used by Google may collect information such as your IP address, time of visit, whether you are a returning visitor, and any referring website. The information generated by Google Analytics will be transmitted to and stored by Google and will be subject to Google's <u>privacy policies</u>. #### Google reCAPTCHA

We use Google reCAPTCHA, a free service provided by Google, Inc., to protect our Site from spam and abuse. Google reCAPTCHA uses advanced risk analysis techniques to decipher humans and bots. Google reCAPTCHA works differently depending on what version is deployed. For example, you may be asked to check a box indicating that you are not a robot or Google reCAPTCHA may detect abusive traffic without user interaction. Google reCAPTCHA works by transmitting certain types of information to Google, such as the referrer URL, IP address, visitor behavior, operating system information, browser and length of the visit, cookies, and mouse movements. Your use of Google reCAPTCHA is subject to Google's <u>Privacy Policy</u> and <u>Terms of Service</u>. More information as to Google reCAPTCHA and how it works is available <u>here</u>.

## 5. Opt-Out Preference Signals

We do not engage in "sales" or "shares" as those terms are defined under applicable laws and therefore, our Site does not recognize the Global Privacy Control ("GPC") signal. If you choose to use the GPC signal, you will need to turn it on for each supported browser or browser extension you use.

Some internet browsers incorporate a "Do Not Track" feature that signals to websites you visit that you do not want to have your online activity tracked. Given that there is not a uniform way that browsers communicate the "Do Not Track" signal, the Site does not currently interpret, respond to or alter its practices when it receives "Do Not Track" signals.

## 6. Security

We maintain commercially reasonable security measures to protect the personal information we collect and store from loss, misuse, destruction, or unauthorized access. However, no security measure or modality of data transmission over the Internet is 100% secure. Although we strive to use commercially acceptable means to protect your personal information, we cannot guarantee absolute security.

## 7. Third-Party Links

The Online Services may contain links that will let you leave the Online Services and access another website. Linked websites are not under our control. We accept no responsibility or liability for these other websites.

## 8. Children's Privacy

The Site and Services are not intended for children under 13 years of age. We do not knowingly collect, use, or disclose personal information from children under 13.

## 9. Notice for Nevada Residents Only

Nevada law allows Nevada residents to opt out of the sale of certain types of personal information. Subject to several exceptions, Nevada law defines "sale" to mean the exchange of certain types of personal information for monetary consideration to another person. We do not currently sell personal information as defined in the Nevada law. However, if you are a Nevada resident, you still may submit a verified request to opt out of sales and we will record your instructions and incorporate them in the future if our policy changes. You may send opt-out requests as provided in the "**How to Contact Us**" section.

## 10. Notice for California Residents Only

The California Consumer Privacy Act, as amended by the California Privacy Rights Act of 2020 ("CCPA"), requires that we provide California residents with a privacy policy that contains a comprehensive description of our online and offline practices regarding the collection, use, disclosure, sale, sharing, and retention of personal information and of the rights of California residents regarding their personal information. This section of the Privacy Policy is intended solely for, and is applicable only as to, California residents. If you are not a California resident, this section does not apply to you and you should not rely on it.

The CCPA defines "personal information" to mean information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular California resident or household. Personal information does not include publicly available, deidentified or aggregated information or lawfully obtained, truthful information that is a matter of public concern. For purposes of this "**Notice for California Residents Only**" section we will refer to this information as "Personal Information."

The CCPA's privacy rights described below do not apply to Personal Information that we collect, process, sell, or disclose subject to the federal Gramm-Leach-Bliley Act and its implementing regulations. Much of the Personal Information that we collect is exempt from the CCPA. Your choices and rights with respect to our use and sharing of that information are subject to our <u>Privacy Notice</u>.

We currently collect and, in the 12 months prior to the Last Updated date of this Privacy Policy, have collected the following categories of Personal Information:

- Unique personal identifiers (device identifier; cookies, beacons, pixel tags, mobile ad identifiers, or other similar technology; customer number, unique pseudonym or user alias; telephone numbers, or other forms of persistent or probabilistic identifiers that can be used to identify a particular consumer or device).
- Personal information described in California's Customer Records statute (California Civil Code § 1798.80(e)) (telephone number, employment, bank account number, credit card number, debit card number, as well as the categories listed in "Identifiers" category above).
- Characteristics of protected classifications under California or federal law (race, color, sex/gender (including pregnancy, childbirth, breastfeeding and/or related medical conditions), sexual orientation, gender identity/expression, age (40 and older), religion (including religious dress and grooming practices), national origin, ancestry, disability (mental and physical including HIV/AIDS, cancer, and genetic characteristics), citizenship status, genetic information, marital status, medical condition (genetic characteristics, cancer or a record or history of cancer), military or veteran status, political affiliations or activities, status as a victim of domestic violence, assault or stalking, request for family care leave, request for leave for an employee's own serious health condition, request for pregnancy disability leave, and retaliation for reporting patient abuse in tax-supported institutions).
- Commercial information (records of personal property, products or services purchased, obtained or considered; other purchasing or consuming histories or tendencies; transaction information).
- Internet or other electronic network activity information (browsing history; search history; and information regarding consumer's interaction with website, application or advertisement).
- Geolocation data.
- Professional or employment-related information (including employment history).
- Education information.
- Inferences drawn from the above information to create a profile about a consumer reflecting the consumer's preferences, characteristics, psychological trends, predispositions, behavior, attitudes, intelligence, abilities, and aptitudes.

We collect Personal Information directly from California residents and from credit reporting agencies, data brokers, public records, and Affiliates. We do not collect all categories of Personal Information from each source.

In addition to the purposes stated above in the section "**How We Use Your Personal Information**" we currently collect and have collected the above categories of Personal Information for the following business or commercial purposes:

- Auditing related to counting ad impressions to unique visitors, verifying positioning and quality of ad impressions, and auditing compliance with this specification and other standards.
- Helping to ensure security and integrity to the extent the use of your personal information is reasonably necessary and proportionate for these purposes.
- Debugging to identify and repair errors that impair existing intended functionality.
- Short-term, transient use, including, but not limited to, non-personalized advertising shown as part of your current interaction with us, provided that your personal information is not disclosed to another third party and is not used to build a profile about you or otherwise alter your experience outside the current interaction with us.
- Performing services, including maintaining or servicing accounts, providing customer service, processing or fulfilling orders and transactions, verifying customer information, processing payments, providing financing, providing advertising or marketing services, providing analytic services, or providing similar services.
- Undertaking internal research for technological development and demonstration.
- Undertaking activities to verify or maintain the quality or safety of a service controlled by us, and to improve, upgrade, or enhance the service controlled by us.
- Advancing our commercial or economic interests.

We have not sold or shared Personal Information in the twelve (12) months preceding the Last Updated date of this Privacy Policy. We do not collect, sell, or share Personal Information of consumers under 16 years of age. We do not use sensitive personal information for purposes other than those allowed by the CCPA and its regulations.

## Rights Under the CCPA

If you are a California resident, you have the following rights to your Personal Information:

- (1) The right to know what Personal Information we have collected about you, including the categories of Personal Information, the categories of sources from which we collected Personal Information, the business or commercial purpose for collecting, selling, or sharing Personal Information (if applicable), the categories of third parties to whom we disclose Personal Information (if applicable), and the specific pieces of Personal Information we collected about you;
- (2) The right to delete Personal Information we collected from you, unless the CCPA recognizes an exception;

- (3) The right to correct any inaccurate Personal Information that we maintain about you;
- (4) If we sell or share Personal Information, the right to opt out of the sale or sharing;
- (5) If we use or disclose Personal Information for purposes other than those allowed by the CCPA and its regulations, the right to limit our use or disclosure; and
- (6) The right not to receive discriminatory treatment by us for the exercise of privacy rights the CCPA confers.

## How to Submit a Request to Know, Delete, and/or Correct

As mentioned above, if you are a California resident who has a financial product or service with us, much of the Personal Information that we collect is exempt from the CCPA and, therefore, is not subject to the rights discussed in this "**Notice to California Residents**" section. Your choices and rights with respect to our use and sharing of that information are subject to our <u>Privacy Notice</u>.

If you are submitting a request on behalf of a California resident, please submit the request through one of the designated methods discussed above. After submitting the request, and if the request is not subject to an exemption or exception, we will require additional information to verify your authority to act on behalf of the California resident.

## **Our Process for Verifying a Request**

If we determine that your request is subject to an exemption or exception, we will notify you of our determination. If we determine that your request is not subject to an exemption or exception, we will comply with your request upon verification of your identity and, to the extent applicable, the identity of the California resident on whose behalf you are making such request.

We will verify your identity either to a "reasonable degree of certainty" or a "reasonably high degree of certainty" depending on the sensitivity of the Personal Information and the risk of harm to you by unauthorized disclosure, deletion, or correction as applicable. To do so, we will ask you to verify data points based on information we have in our records concerning you.

## Shine the Light Law

We do not disclose personal information obtained through the Services to third parties for their direct marketing purposes. Accordingly, we have no obligations under California Civil Code § 1798.83.
